PROXY VOTING

We urge all Unit Owners to make every effort to attend the Annual Meeting. However, if circumstances preclude your presence, you may designate another individual to vote on your behalf by completing and submitting the enclosed Proxy Form.

PROXY FORM:

Any Unit Owner who is unable to attend the Annual Meeting should complete the form. You should designate someone to vote your proxy, as explained on the Voting Procedure instructions. You may note on the bottom of the Proxy Form any special instructions. PLEASE DESIGNATE A PROXY IF YOU CANNOT ATTEND THE ANNUAL MEETING. This will ensure a quorum at the meeting. (If you are not sure if you will be able to attend the meeting, you can give a proxy and it is automatically revoked if you are able to attend the meeting.) You must be an owner "in good standing".

VOTING PROCEDURE

The Condominium Documents require that the vote of each unit be made by the actual Unit Owner of records as listed on the Unit Deed and recorded with the Middlesex County Registry of Deeds, or by written Proxy. In the event of a corporation, an officer or agent may vote; in the event of a Trust, either the Manager of the Trust or a person with a Beneficial Interest in the Trust designated by the Manager may vote. Votes by each Unit must be voted as an entity and cannot be split between two (2) or more people. Unit Owners may complete the attached designation forms (DESIGNATION OF UNIT OWNER TO CAST VOTE OF UNIT NUMBER) designating which person may vote. In the event a designation is not made by the Unit Owners, the Trustees may determine which one of the Unit Owners may vote. You must be an owner "in good standing".

TRUSTEE NOMINATIONS

On behalf of the Association, we are soliciting candidates to fill 4 positions on the Board for two (2) year terms and 2 one (1) year term. If you wish to nominate yourself or to nominate another individual, please mail the Nomination Ballot to the Board of Trustees no later than October 15 2021. If you are placing another individual's name in nomination, you must have that person's prior consent.

On the night of the meeting, nominations will be accepted from the floor, however, we encourage submission of prospective candidate names prior to October 15, 2021. Prepared voting ballots will expedite voting procedures at the meeting. They will be available prior to the meeting at the Registration Table.

Although no particular background or specific experience is required to be a Trustee, two elements are most desirable:

Ability and Commitment to Devote Time

Trustees serve as volunteers. Meetings are typically held Monthly in the evening for 2.5 hours. Presently meetings are conducted at Country Estates Complex, Bldg. I ** on a monthly basis. Meeting schedule will be determined by the new board. Also, Trustees assume other responsibilities which may require several additional hours each month.

Ability to be impartial

Trustees do not act as individuals. They serve as members of the board. Trustees should have the motivations to evaluate any issue or subject according to the best interests of the Association as a whole, not according to personal preference.

Country Estates Condominium needs committed and active leadership on its Board of Trustees. All Unit Owners are encouraged to carefully consider the possibilities for nominating Trustees. Remember we are currently a self-managed association. Trustee position is a nonpaying position. It is an investment in your investment.

Please Note: We shall request all nominated candidates to speak for two minutes to the audience prior to the election about how he or she may contribute as a Trustee to the success of the Association.
